

**Memorandum of Understanding
Between
Moreno Valley Unified School District
&
Moreno Valley Educators Association**

**Full Day Transitional Kindergarten
August 31, 2022**

The Moreno Valley Unified School District ("District") and the Moreno Valley Educators Association ("MVEA") agree to amend the terms and conditions of full day Transitional Kindergarten (TK) classes for the 2022-2023 school year.


- The length and number of recess/lunch breaks for students shall be the same as other TK and primary grade classes (i.e. one recess break, one lunch, etc.).
- Class sizes for all TK classes at all elementary schools designated to UPK grant class size ratios shall be 1:12 for the 2022 - 2023 school year. The parties agree to amend Article XIII, Section 2(a)(1) of the Collective Bargaining Agreement to class size maximum of 24. The parties further agree to reconvene to meet and confer on the class size ratios for the 2023 - 2024 school year.
- The District shall attempt to keep the TK classes together and in accordance with Title V regulations.
- Current half-day TK teachers who would prefer not to switch to Full Day TK may submit a voluntary transfer to another grade level vacancy.
- The District agrees to provide appropriate professional development for full day TK teachers at the elementary including curriculum training and the opportunity to observe TK teachers within the District.
- The District shall provide equipment and supplies pursuant to Article XI- Professional Working Environment, Section 5
- Each Full Day Transitional Kindergarten teacher will be provided an Instructional Assistant for 1.75 hours per day that will be an addition to grant designated staffing and class size ratios by the District. This does not include IA mandatory break times.

- Full Day Transitional Kindergarten (TK) teachers shall receive up to eight (8) substitute days for the 2022-2023 school year and the 2023-2024 School year.

For the 2022 - 2023 school year, employees shall receive up to three (3) sub-days which may be utilized for extra classroom support during the first thirty (30) calendar days as of the date of this agreement. Up to five (5) days shall be utilized for on-site/in-class assessments and District Professional Development until the end of the school year

For the 2023 - 2024 school year, employees shall receive up to three (3) sub-days which shall be utilized for extra classroom support during the first three (3) days of the school year. Up to five (5) days shall be used for on-site/in-class testing and District Professional Development until the end of the school year. The District and the Association shall reconvene to bargain the substitute dates for TK teachers for the 2024-2025 school year.

- The District agrees to provide materials in the manner discussed with the joint District/MVEA TK Implementation Committee. Teachers shall receive the necessary materials for implementation. New TK classes shall receive up to \$2000.00 worth of supplies, not including standard classroom furnishings (*see Addendum A*).
- The District and MVEA understand that this MOU serves as an amendment to the full day TK classes for the 2022-2023 school year. As the implementation of the full day TK program expands to more sites, the District and MVEA will reconvene to discuss any other possible issues.
